CALIFORNIA ADULT EDUCATION LEADERSHIP INSTITUTE: 2019

Introduction

The California Adult Literacy Professional Development Project (CALPRO) in conjunction with the California Department of Education (CDE) is seeking nominations and applications for the 2019 *California Adult Education Leadership Institute* (the Institute). We are seeking aspiring and new administrators (defined as three or fewer years) for the Institute. This is an opportunity for your organization to nominate an aspiring or new administrator from your adult education program to attend. For the 2019 year we will accept up to 24 nominations for participation in the Institute. Priority registration will be given to nominees with the most recent appointment date to their administrative position.

More than 600 of California's leading adult educators have participated in this program since its inception in 1985. The Institute covers topics and skills that new and aspiring adult education administrators need to perform their jobs effectively. Topics for the one-year institute will focus on:

- Fiscal and Personnel Management
- Collaborations and Partnerships
- Career Pathways
- Data Analysis and Data-Based Decision Making
- Public Relations and Program Marketing
- Adult Education Block Grant
- Strategic Planning
- Instructional Leadership
- The Workforce Innovation and Opportunity Act (WIOA)

Institute participants have numerous opportunities for networking with experienced and new adult education administrators as well as representatives from CDE and the three State Leadership Projects (OTAN, CASAS and CALPRO). Participants will complete a pre-assignment in preparation for the Institute as well as interim assignments between training sessions. These assignments will require 4-6 hours each to complete. Participants are expected to use the skills learned through collaborative team-building and problem-solving activities at their own sites.

The Institute will be held over a total of six days. Following are the scheduled dates:

- January 24-25, 2019 the two-day winter session, to be held in Sacramento, California;
- April 11-12, 2019—the two-day spring session, to be held in Ontario, California; and
- June 20-21, 2019—the two-day summer session, to be held in Sacramento, California.

Workforce Innovation and Opportunity Act (WIOA)-funded programs are eligible to apply. Completed applications must be received in the CALPRO office via mail or fax by **November 16, 2018**. Based on CDE approval of candidates, CALPRO will notify selected participants and their nominators by December 7, 2018.

The sponsoring agency is expected to support the participant's release time to attend. CALPRO will reimburse the participants the cost of lodging, travel and meals.

- 2. **Nominee's statement of interest (page 4),** sharing your area of interest and reasons for wanting to participate in this program.
- 3. **Nominator's letter of recommendation,** indicating applicant's leadership skills and current assignment as a new (within the past three years) adult education administrator.
